Dear WVCHIP Member or Guardian:

This letter to tell is to you about upcoming changes to West Virginia Children's Health Insurance Program (WVCHIP) benefits.

Starting **July 1, 2023**, WVCHIP is changing its covered services so WVCHIP and Medicaid members in Mountain Health Trust (MHT) program will have the same benefits. WVCHIP members will still have all the same services you receive today. A list of benefits is attached.

Your or your child's health plan and cost sharing (copays and premiums) <u>will not</u> <u>change</u>.
